1. THIS IS A FIVE MEMBER TEAM EVENT. *A BOWLER MAY ONLY BOWL ON ONE TEAM. THERE ARE NO RE-ENTRIES.*
2. OPEN TO ALL USBC BOWLERS SANCTIONED THROUGH MONMOUTH COUNTY USBC.
3. BOWLERS DO NOT HAVE TO BE MONMOUTH COUNTY RESIDENTS.
4. THIS IS AN OPEN SCRATCH TOURNAMENT.
5. ALL TEAM MEMBERS MUST BOWL IN THE SAME BOWLING CENTER. EACH INDIVIDUAL MUST HAVE BOWLED 21 GAMES IN ONE LEAGUE IN THAT CENTER BY MARCH 23RD, 2019, INCLUDING GAMES BOWLED IN 2018 SUMMER LEAGUE. ALL ENTRANTS MUST BE CERTIFIED AT LEAST 30 DAYS PRIOR TO DATE OF TOURNAMENT (MARCH 30TH, 2019). A LEAGUE STANDING SHEET MUST BE SUBMITTED WITH THIS APPLICATION. FAILURE TO DO SO WILL CAUSE THE APPLICATION TO BE CONSIDERED INCOMPLETE AND WILL NOT BE PROCESSED UNTIL A STANDING SHEET IS SUBMITTED. ANY BOWLER NOT VERIFIED BY THE PROCEDURE WILL BE DISQUALIFIED.
6. CAPTAINS MUST CHECK IN 45 MINUTES PRIOR TO BOWLING. CAPTAINS WILL CHECK IN WITH ALL BOWLERS' USBC CARDS. ANY SUBSTITUTES ENTERED AT THIS TIME WILL REQUIRE A USBC CARD AND LEAGUE STANDING SHEET FOR VERIFICATION.
7. WINNERS WILL BE PAID IMMEDIATELY AFTER THE TOURNAMENT. FAILURE TO PROVIDE PROOF OF ELIGIBILITY WILL RESULT IN DISQUALIFICATION.
8. ENTRY FEE WILL BE 175.00 PER TEAM. PRIZE RATIO WILL BE AT LEAST 1 PRIZE IN TEN.
9. CONDUCT: ANY INDIVIDUAL CHARGED BY THIS EVENT MANAGEMENT COMMITTEE WITH MISCONDUCT AS DESCRIBED IN USBC PLAYING RULE 17A AND 17B DURING PLAY IN THIS TOURNAMENT MAY BE PENALIZED BY ANY OR ALL OF THE FOLLOWING:

 - B. SUSPENSION FROM FURTHER PARTICIPATION IN THIS EVENT.
