Tournament Rules

1. **ELIGIBILITY:** Open to all Monmouth County USBC members who are currently bowling in this seasons winter leagues or who have bowled at least 21 games in a league this past summer season. If using summer eligibility and not currently a paid member in the association, membership fees must be paid prior to entering the tournament.
2. **HANDICAP:** Handicap is based on 100% of the difference between the teams highest entering average and a scratch figure of 460 per team.
3. **ENTERING AVERAGES:** All bowlers will use their highest certified USBC average for 21 games or more in the following order
 - a. WINTER SEASON FROM PREVIOUS YEAR 2017-2018.
 - b. SUMMER SEASON FROM PREVIOUS YEAR 2018.
 - c. CURRENT WINTER SEASON 2018-2019.
 - d. COMPOSITE AVERAGES WILL NOT BE USED.
 - e. RULE 319A if current season average is the only average available it is the bowlers responsibility to provide proof of average at the time of bowling. All others will bowl scratch (230) USBC Rule 319a2 ten pin increase is waived. Rules 319d and Rule 319e also will not apply. Rule 319c is in effect allowing tournament management to adjust or rerate any average upward. If the assigned average is not acceptable to the bowler, the entry fee will be returned.
 - f. Any bowler whose entering average was compiled in a PBA or "Challenge condition " league, the conversion chart from bowl.com will be used if your only average is from a challenge or a sport condition league
4. **QUALIFYING AVERAGE:** It shall be the responsibility of each bowler to verify the accuracy of his or her average, whether submitted by the bowler, partner, or any other representative. Failure to use proper average, scores will be disallowed and the team will be disqualified. If higher Rule 319e applies
5. **MULTIPLE ENTRY:** Each team shall consist of 1 man and 1 woman. Any bowler may bowl unlimited times as long as it is with a different partner.
6. **TOURNAMENT FORMAT:** All teams will bowl 3 games on 1 pair of lanes. Total pin fall both scratch and with handicap included will determine final positions standings. Teams may win a prize in both scratch and handicap divisions. Ties for first place in either division will be decided in a 3 game roll off within 10 days. Prize monies will be combined and divided equally among all other position ties. All tournament rules apply during the roll off. Bowlers arriving late will bowl in the same frame as the team is bowling. No score for any missed frames. Prizes will be split 75% handicap and 25% scratch.
7. **CONDUCT:** Any individual that is charged by this tournament committee with misconduct, as described in USBC Rule 17b, during play of this tournament may be penalized by all or any of the following, loss of prize winnings for this event, suspension from participation in this event, refusal of future participation in this event.
8. **GROUPS:** Groups wanting to be scheduled together may make party reservations while spaces remain available prior to the entry closing date.
