**Entry Fee - \$80.00 per team if entry is postmarked or paid via PayPal by February 22<sup>nd</sup>. \$90 per team for walk-in entries (space permitting) and all entries postmarked or paid via PayPal after February 22<sup>nd</sup>. The additional \$10 per team will be added to the prize fund. Entry Fee Breakdown. Lineage \$31, Prizes \$46, Expenses \$3.**

**TOURNAMENT FORMAT:** 4 Person Baker Team Tournament.  
800 Team Maximum Combined Average.  
10 Baker Qualifying games.  
Top 40% of the field to advance to the semi-finals.  
All qualifying scores will carry forward to the semi-finals.  
Semi-Finalists will bowl 3 additional Baker match games. The winners of each match will receive a 30 pin bonus.  
The top five teams will advance to the stepladder finals.

**PRIZE FUND** - Prizes will be paid to at least 1 out of every 6 teams.

**Eligibility:** Open to all Monmouth County USBC Sanctioned Youth Bowlers (non-members can sanction at event). Entering average will be the highest current league average, based on a min 21 games as of February 1, 2019. High School averages will be counted as long as 21 games have been bowled. If no current league average or any current average with less than 21 games we will use the highest 2017-2018 Winter League average with a minimum of 21 games. Please bring proof of average (current league sheet). This tournament is open to any combination of girls and boys. Bowlers using a sport or challenge average will be re-rated according to the USBC average conversion chart. Sport or Challenge average will be used if bowler does not have current house shot average.

**Rules:** This is a handicap tournament. The handicap will be 80% of the difference of the team average vs. scratch score of 800 divided by 4. All averages will be verified. If any average submitted is found lower than the actual average, the scores may be disqualified. If submitted average is higher, then any prize winnings will be based on the submitted average. **It is the responsibility of each bowler to verify their average.**

All games bowled in the Tournament are sanctioned by USBC and all Tournament rules and awards apply.  
Rule 319a-2 & 319E are waived.

In accordance with USBC rules there will be no altering of any ball surface after the first ball of competition. Any bowler found to have violated this rule will have his team disqualified immediately from competition with no refund of entry fee.
